Background

Many European Chambers benefit from **EU funding**, to realise their objectives and finance part of their initiatives. Structure

Participants should therefore **come prepared with ideas and best practise**. Every participating Chamber should leave the seminar with **at least 1 concrete project opportunity** to develop.
